This report documents the law enforcement services and activity within the City of Litchfield Park. The Maricopa County Sheriff's Office has a contractual agreement with Litchfield Park and provides the law enforcement services. This report reflects the monthly activity along with a comparison of the previous 3 months activity. A call for service or law enforcement activity does not always generate a written document by the Sheriff's Office.

This report provides a breakdown of the types of criminal activity within the City of Litchfield Park such as assaults, burglaries, and thefts. Also included are the traffic citations issued, traffic accidents, and subsequent drug and alcohol violations. The Uniform Crime Reporting procedure is being utilized which is the standard for crime reporting by the FBI. A brief synopsis is provided at the end of this report which documents any significant or notable incidents which have occurred.
