Note 1. Summary of Significant Accounting Policies

The Annual Expenditure Limitation Report (AELR) is presented on the basis of accounting prescribed by the *Uniform Expenditure Reporting System* (UERS), as required by Arizona Revised Statutes §41-1279.07. The AELR excludes expenditures, expenses, or deductions of certain revenues specified in the Arizona Constitution, Article IX, Sec. 20 from the total expenditures, expenses or deductions in the fund financial statements.

In accordance with the UERS requirements, a note to the AELR is presented below for any exclusion claimed in part II and each subtraction or addition in the reconciliation that cannot be traced directly to an amount reported in the annual financial statements. All references to financial statement amounts in the following notes refer to the Statement of Revenues, Expenditures, and Changes in Fund Balances for the Governmental Funds, Statement of Revenues, Expenses, and Changes in Net Position for the Proprietary Funds, Statement of Cash Flows for the Proprietary Funds, and the Statement of Changes in Fiduciary Net Position, as applicable.

Note 2. Dividends, Interest and Gains on Sale or Redemption of Investment Securities

No exclusions were claimed for expenditures or expenses of interest, dividends, or gains on the sale or redemption of investment securities and \$582,043 of unexpended revenues have been carried forward to future years.

Note 3. Intergovernmental Revenues

The following schedule presents revenues from which exclusions have been claimed for federal grants and aid and amounts received from the State of Arizona, including Highway User Revenues in the Governmental Funds:

Note 3. Intergovernmental Revenues, Continued

The exclusion for Highway User Revenues includes amounts expended in the Highway User Revenue Fund totaling \$28,283. The exclusion consists of \$610,326 of Highway User Revenue Funds received in the current fiscal year and \$582,043 carried forward from previous years.

Note 4. Expenditures of Separate Legal Entities

The subtraction of \$930,475 for separate legal entities established under Arizona Revised Statutes consists of expenditures of special assessment districts included within the City’s reporting entity but not included in the Economic Estimates Commission base limit calculations, and are reported as follows in the financial statements.
