PROVISIONS: THE APPLICANT IS ADVISED THAT ISSUANCE OF THIS PERMIT WILL NOT RELIEVE RESPONSIBILITY OF THE OWNER OR OWNER'S AGENTS TO COMPLY WITH THE PROVISIONS OF ALL LAWS AND ORDINANCES, INCLUDING FEDERAL, STATE, AND LOCAL JURISDICTIONS, WHICH REGULATE CONSTRUCTION AND PERFORMANCE OF CONSTRUCTION OR WITH ANY PRIVATE DEED RESTRICTIONS OR REQUIREMENTS OF THE APPLICABLE SANITARY OR FIRE DISTRICT OR PUBLIC UTILITY.

***PLEASE NOTE: If the processing of a building permit application is not completed and permit issued within 180 days of application date, the application becomes invalid and re-application will be required. In addition every building permit issued shall become invalid unless the work on the site authorized by such permit is commenced within 180 days after its issuance, or if the work authorized on the site by such permit is suspended or abandoned. Proof that work has been suspended or abandoned shall be determined if 180 days has passed since the last scheduled building inspection. The Building Official is authorized to grant in writing a maximum of two (2) extensions of time, for periods not more than 180 days each. The extension shall be requested in writing and justifiable cause demonstrated. It is the owner's responsibility to request an extension in writing to the Building Official. The Building Official is authorized to suspend or revoke a permit issued under the provisions of the IBC Section 105.6, wherever the permit is issued in error or on the basis of incorrect, inaccurate or incomplete information, or in violation of any ordinance or regulation or any provisions of this code.

WORK CANNOT BE COVERED UNTIL INSPECTED AND APPROVED. TO KEEP YOUR PERMIT ACTIVE AND AVOID UNNECESSARY EXPIRATION IT IS IMPORTANT THAT YOU CALL FOR INSPECTION AT LEAST EVERY 180 DAYS. BUILDING PERMIT FEES ARE BASED ON VALUE OF PROJECT. FEES FOR PLAN REVIEW ARE DUE AT TIME OF SUBMITTAL. PLAN REVIEW FEES ARE 65% OF THE BUILDING PERMIT FEE. ANY CHANGES MADE TO THE APPROVED SET OF PLANS MUST BE RESUBMITTED FOR REVIEW AND ARE SUBJECT TO THE HOURLY RATE CALCULATED FOR THE BUILDING INSPECTOR/PLAN REVIEWER, PURSUANT TO RESOLUTION 11-324 EXHIBIT B.
