Notice is hereby given that the Board of Adjustment of the City of Litchfield Park will conduct a Public Hearing on line via Zoom at 7:00 p.m. on **Thursday, June 3, 2021**.

**ATTENDANCE AT THIS HEARING WILL BE ONLINE/TELEPHONIC ONLY VIA ZOOM.**

The purpose of the Public Hearing is to consider granting a zoning variance, **Case No. ZA.21-03**, on a specified lot located at **14044 W. Greentree Drive South, Litchfield Park, Arizona**.

The Board of Adjustment will consider a request for a variance from Litchfield Park Zoning Code Section 31.03 Accessory Uses and Structures, Paragraph d.3. Setbacks, as it applies to Lot 86 located in the Litchfield Greens Subdivision in Litchfield Park, Arizona, also known as **14044 W. Greentree Drive South**, to allow a shade accessory structure to encroach approximately 4'6" into the required 10' side yard setback and to encroach approximately 6' into the 10' setback distance required from the primary structure.
